This tag is displayed to notify the motorist responsible that this vehicle may be in violation of Hillsborough County Ordinance 98-48, Amendment 00-18.

**Handicap Parking**

It is illegal to use any space designated as a Disabled parking space (those with a posted sign and blue painted lines on the ground), on public or private property, unless the vehicle displays a disabled parking permit from the rearview mirror or the license plate. It is illegal to block a designated Disabled parking space, ramp, access aisle, or walkway, on public or private property. Violations are subject to a \$260.00 fine.

**Fire Lane Parking**

It is illegal to park a vehicle in an area marked as a fire lane with signs and/or yellow painted lines on the ground. Violations are subject to a \$43.00 fine.

**Right-of-Way Parking**

It is illegal to park a vehicle within 30 feet from the edge of roadway on any road, street or highway within the unincorporated areas of Hillsborough County, except when directed by the Sheriff or his deputy. Violations are subject to a \$40.00 fine and being towed.

**For Sale Parking**

It is illegal to park a vehicle along the side of the road or in a parking lot, on public or private property, for the purpose of selling the vehicle by the owner, unless authorized by municipal or County regulation. Violations are subject to a \$40.00 fine and being towed at the owner's expense if the vehicle is parked for more than 24 hours.

**Sidewalk Parking**

It is illegal to park a vehicle on a sidewalk. Violations are subject to a \$30.00 fine.

**FLORIDA PARKING LAWS**


**YOU CANNOT PARK A VEHICLE:**

- Beside another vehicle parked or stopped at a curb
- On or blocking a sidewalk (even in your own driveway)
- Within an intersection
- On a crosswalk
- On or within 50 feet of a railroad track/crossing
- On a bicycle path or exclusive bicycle lane
- In front of a public or private driveway
- Within 15 feet of a fire hydrant
- Within 20 feet of a crosswalk at an intersection
- Within 30 feet of a stop sign or a traffic control device on the side of a roadway
- Within 20 feet of the entry of a fire station
- On or in a marked fire lane
- Against the flow of traffic
- Within 10 feet of another vehicle, which would impede traffic flow on the roadway

**WHEN PARKING ON A TWO WAY ROAD:**


- Park in the direction of authorized traffic movement
- Wheels should be parallel to and within 12 inches of the curb or edge of roadway
- Leave a minimum of 10 feet from a vehicle parked on the opposite side of the roadway
