New Proposed amendments that are to be open until June 15th:

<u>Motion</u>: to amend Article VII, General covenants and Restrictions, page21, section 6, next to the last sentence from: (No storm doors or screen doors are permitted on the front door of any dwelling)

To: (Full view storm doors are permitted on the front door of any dwelling. The definition of full view is: The frame portion of the storm door may not be wider than tree inches. Absolutely no storm doors with kick plates will be allowed) (If screens are to be used, all screens for full view doors must be outfitted or retrofitted with iffvisible screen material. (Storm doors are to match the color of the front door trim)

(Approval from the ACC prior to installations is REQUIRED)

Status: To date 5/4/04 there is 11 votes FOR and 11 votes AGAINST. The required amount of signatures is 35 or 2/3 of the community.

<u>Motion:</u> to amend Article VII, General Covenants and Restrictions, page21, section 6, last sentence from: (No above-ground swimming pools, free-standing storage sheds or outbuildings, screening or front porches or garages, antennas or solar collectors are permitted on any lot)

To: (Free-standing storage sheds or out buildings are permitted with the following limitations)

- 1) Appearance shall be similar in appearance and utilize the same color scheme as the house.
- 2) Structure shall be maintained in such a manner as to preserve a like new appearance.
- 3) Structure shall be of frame or block construction.

Status: To date 5/4/04 there is 25 1/2 votes FOR and 1 votes AGAINST. The required amount of signatures is 35 or 2/3 of the community.

To: (if above motion passes to amend item 3 to also state Structure may be made of metal, provided it is contained inside a fence)

Status: To date 5/4/04 there is 4 votes FOR and 20 votes AGAINST. The required amount of signatures is 35 or 2/3 of the community.

To: (if above motion passes to amend item 3 to also state Structure may be made of plastic, preferably Rubbermaid, provided it is contained inside a fence)

Status: To date 5/4/04 there is 7 votes FOR and 11 votes AGAINST. The required amount of signatures is 35 or 2/3 of the community.

Fifteen-minute recess for voting took place. Upon reconvening the results, which are listed above, were announced.

Motion raised by Tom Martinez to propose adding a sign at the entrance of Aberdeen Creek that states No Solicitation "Motion to be reviewed."
